ORDER :

The Government have examined the issue of the transfer of the teachers in schools under the private managements and they direct that

1) The transfer of sister teachers belonging to the ecclesiastical order from educational institutions in one district to the educational institutions in another district under the same management could be made with the prior approval of the Joint Director of School Education, provided the seniority of any lady teacher working in the latter institution is not affected.

ii) a) the transfer of other teachers under private managements including mission managements having more than one school shall be made within the district itself, subject to the maintenance of common seniority list by the management of the schools duly approved by the District Educational Officer.

b) The transfer of teachers shall be made only in the beginning of the academic year with the approval of the District Educational Officer (By order and in the name of the Governor of A.P.)
